• Pfizer, FDA, and CDC have **deliberately hidden COVID vaccine data.** A U.S. District Judge ordered Pfizer to release the data submitted to FDA from its clinical trials in support of a COVID-19 vaccine license. Before the ruling, **FDA planned to suppress the data for the next 75 years,** which the agency claimed was necessary, in part, because of its "limited resources."



• The government of New South Wales, Australia, publishes a weekly Covid-19 Surveillance Report that recently showed that **4 in every 5 deaths from COVID-19 were in the** vaccinated.

• Recent data from the UK Health Security Agency confirms **deaths are rising dramatically among the triple vaccinated** population while declining steadily among the unvaccinated population in England. Recent figures showed the fully vaccinated accounted for 9 in every 10 COVID-19 deaths over the past month, and the triple vaccinated accounted for 4 in every 5 COVID deaths.

• While the CDC says myocarditis is a mild disease, cardiologists know otherwise. CDC's preliminary data, revealed that nearly half of the young people diagnosed with myocarditis still had symptoms three months later, and 39% had activity restricted by their physician. We know

this serious adverse event frequently occurs in teens. However, no one knows how often it occurs in younger children. This is of major concern for babies and younger children.

• A study published in *Clinical Infectious Diseases* out of Hong Kong showed **1 out of every 2,700 12- to 17-year-old boys** are being **diagnosed with myocarditis** following the 2nd dose of Comirnaty vaccine, or 37 per 100,000 vaccinated.

Recent VAERS data shows that there were **26,059 deaths** and **1,995,936 total adverse events** which includes **211,584 serious injuries** reported after COVID vaccines between 12.14.20 and 3.18.22.

U.S. VAERS data from Dec. 14, 2020, to March 18, 2022, for 5 to 11-year-olds show: • 9,463 adverse events, including 228 rated as serious and 5 reported deaths.

U.S. VAERS data from Dec. 14, 2020, to March 18, 2022, for 12 to 17-year-olds show: • 30,591 adverse events, including 1,755 rated as serious and 42 reported deaths.
